### PLAINTIFF'S THIRD AMENDED COMPLAINT

The Plaintiff, Kenosha County resident Kevin Mathewson by his Attorneys, Rose and Rose Attorneys hereby filed the following complaint and shows to the Court as follows:

 That the Plaintiff, KEVIN E. MATHEWSON (hereinafter "MATHEWSON") is an adult resident of the State of Wisconsin, with an address of P.O. Box 2295 Kenosha, WI 53141.

- 2. That the Defendant, RAYMOND KARIM ROBERTS (hereinafter "ROBERTS") is an adult resident of the State of Wisconsin, residing at 1527 Sheridan Rd UNIT F Kenosha, WI 53140 ROBERTS previously misrepresented his address in his answers.
- 3. That MATHEWSON is a local business owner working as a Private Investigator for KM Investigations and Security, LLC.
- 4. That at the time the first complaint was filed on March 7, 2022, ROBERTS was out on bail for Milwaukee CO 2020CM001179 for OWI (2<sup>nd</sup>) and Endangering Safety (Operating Firearm While Intoxicated) to which, upon information and belief, he has plead guilty to both and is awaiting sentencing.
- 5. That ROBERTS has several other criminal convictions that remain of record and unreversed including two counts of "neglect of a child" where he stipulated to the facts within the criminal complaint to hitting his sons with a belt causing welts.

### False and Defamatory Public Statements Made By ROBERTS About MATHEWSON

6. That on October 8, 2020 ROBERTS made a Facebook post calling

### MATHEWSON a "White Nationalist"

- 7. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT A.**
- 8. That on or about October 8 and 9, 2020 ROBERTS sent several emails to MATHEWSON and members of the Kenosha Police

  Department and several Kenosha County Residents claiming

  MATHEWSON is a domestic terrorist, white nationalist, has children that attend a local school and MATHEWSON is using his children as suicide bombers, and MATHEWONS is affiliated with the terror cell in Michigan that plotted to kidnap the governor.
- 9. A true an accurate copy of this email chain is attached herein and labeled as **EXHIBIT B**
- 10. That on or about October 19, 2020 ROBERTS made a post on Facebook wherein he called MATHEWSON a White Nationalist. He also posted MATHEWSON's home address to incite violence against MATHEWSON's family and MATHEWSON himself. A known violent felon and gang member, Raymond Lopez reacted to the address and reposted it. ROBERTS also knowingly and falsely claimed in this post that MATHEWSON was training his children to be suicide bombers and

claimed MATHEWSON's children would blow up the school in which they attend.

- 11. A true an accurate copy of this post is attached herein and labeled as EXHIBIT C, C2, and C3. Exhibits C2 and C3 are zoomed-in copies.
- 12. That MATHEWSON reported these disturbing comments to the Kenosha Police Department on or about October 20, 2020. Detective Correa and DDA Angelina Gabriele ostensibly warned ROBERTS to stop threatening MATHEWSON's children.
- 13. That on or about October 22, 2020 ROBERTS made a post on Facebook claiming that MATHEWSON is a white nationalist and insinuated he is racist.

A true an accurate copy of this post is attached herein and labeled as **EXHIBIT D.** 

- 14. That on or about November 12, 2020 Roberts made a post on Facebook wherein ROBERTS called MATHEWSON a white supremacist.
- 15. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT E.**
- 16. That on or about December 9, 2020 ROBERTS wrote an email to the

- entire county board and several news organizations claiming

  MATHEWSON is a terrorist, white supremacist, and leads a terror group.
- 17. A true an accurate copy of this email is attached herein and labeled as **EXHIBIT F.**
- 18. That on or about December 18, 2020 ROBERTS made a Facebook post that recruited members of the public to subscribe MATHEWSON to "junk" email lists as an attempt to harm MATHEWSON.
- 19. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT G.**
- 20. That on or about December 23, 2020 ROBERTS made a post on Facebook telling the public at large where MATHEWSON was eating with friends, encouraging people to find MATHEWSON and do him harm.
- 21. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT H.**
- 22. That on or about December 27, 2020 ROBERTS made a post on FACEBOOK calling MATHEWSON a terrorist and white supremacist.
- 23. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT I.**

- 24. That on or about January 4, 2021 ROBERTS made a post calling MATHEWSON a terrorist.
- 25. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT J.**
- 26. That on or about February 4, 2021 ROBERTS made a Facebook post calling MATHEWSON a domestic terrorist and racist.
- 27. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT K.**
- 28. That on or about July 18, 2021 ROBERTS made a Facebook post in which he encourages someone to go to the Kenosha Police Department to buy art from MATHEWSON.
- 29. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT L.**
- 30. On or about August 11, 2021 ROBERTS made a post on Facebook knowingly and falsely claiming that MATHEWSON was sending military veterans death threats via phone and email. He again mentions that MATHEWON is intending to use MATHEWSON's children as suicide bombers
- 31. A true an accurate copy of this post is attached herein and labeled as

### EXHIBIT M.

- 32. On or about August 11, 2021, ROBERTS made a post on Facebook asking people to leave negative reviews on MATHEWSON's business's google page to hinder MATHEWSON's likelihood of being retained.
- 33. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT N.**
- 34. That on or about August 15, 2021 ROBERTS made a post calling MATHEWSON a white supremacist and a racist.
- 35. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT O.**
- 36. On or about August 18, 2021, ROBERTS made a post on Facebook mocking KPD police Detective Correa when Correa asks ROBERTS to stop making threats to MATHEWSON about suicide bombings.
- 37. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT P.**
- 38. On or about February 28, 2022 ROBERTS sent an email to each and every member of the Kenosha City Council falsely and with malice, claiming that MATHEWSON is listed on Southern Poverty Law Center as a white supremacist.

- A true an accurate copy of this post is attached herein and labeled as 39. EXHIBIT Q.
- 40. On or about March 4, 2022 ROBERTS made a Facebook post wherein ROBERTS publicly admits that his comments about MATHEWSON being listed on the Southern Poverty Law Center as being a white supremacist was a lie.
- A true an accurate copy of this post is attached herein and labeled as 41. EXHIBIT R.
- 42. On or about March 6, 2022 MATHEWSON Sends email to ROBERTS with a list of demands to avoid court litigation.
- A true an accurate copy of this post is attached herein and labeled as 43. EXHIBIT S.
- On or about March 7, 2022 ROBERTS wrote an email to 44. MATHEWSON indicating that he will not give in to the demands.
- 45. A true an accurate copy of this post is attached herein and labeled as EXHIBIT S.
- 46. On or about March 7, 2022 ROBERTS made a post on Facebook indicating that would not give in to demands from MATHEWSON

- calling MATHEWSON a white supremacist and racist.
- 47. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT T.**
- 48. On or about March 9, 2022 after receiving the complaint of this action, ROBERTS posted a Facebook post associated MATHEWSON with a domestic terror group.
- 49. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT U.**
- 50. On or about March 11, 2022 after receiving the complaint of this action ROBERTS posted a Facebook post calling MATHEWSON a white supremacist four times, a racist twice and finally, a terrorist.
- 51. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT V.**
- 52. In a self-recorded video posted to Facebook on March 17, 2022 two days after MATHEWSON filed his First Amended complaint,

  ROBERTS likened Plaintiff to a domestic terrorist and white supremacist multiple times.
- 53. In March 17, 2022 video, ROBERTS claimed MATHEWSON was violating state law and Wisconsin Department of Safety and Professional

Services guidelines by abusing his professional Private Investigator
License by using authorities his license grants him to attack
"marginalized communities."

- 54. In March 17, 2022 video, ROBERTS claimed MATHEWSON engaged in a long-thought-out conspiracy to defund a minority area of the City of Kenosha by being elected Alderman and doing the following: "So just a really kooky bunch of nasty people [Mathewson] actually went out of his way to represent a multi-minority district and then once in office he worked with some of the stronger conservatives to get that area defunded once he was done and I can you can show this all public record once he was done doing what he was doing that area he bought a house on the complete opposite side of town and left."
- 55. In a self-recorded video posted to Facebook on March 25, 2022 ten days after MATHEWSON filed his First Amended complaint,

  ROBERTS likened Plaintiff to a domestic terrorist and white supremacist multiple times.
- 56. In March 25, 2022 Video, ROBERTS said the MATHEWSON harassed a local African-American Business owner named Augustus

Harris and his family.

- 57. ROBERTS did not name Harris in his video, but the facts of what ROBERTS alleged are identical to that of the facts that occurred to Harris on May 17, 2020, other than the defamatory statements that MATHEWSON harassed Mr. Harris and his family.
- 58. Roberts made the accusation in ¶ 56 with ACTUAL MALICE, as it is completely untrue and MATHEWSON is actually friends with Mr. Harris.
- 59. In March 25, 2022 Video, ROBERTS once again said that

  MATHEWSON was violating state law and Wisconsin Department of

  Safety and Professional Services guidelines by abusing his professional

  Private Investigator License by using authorities his license grants him to

  attack people by running background checks on them illegally.
- 60. The only special authorities a Private Investigator License in

  Wisconsin gives one, is the ability to access DPPA (Driver's Privacy and

  Protection Act) data. MATHEWSON has never used his DPPA

  exemption for a reason other than a lawful reason and in direct

  connection to a court case or at the direction of a licensed attorney.
- 61. MATHEWSON's past DPPA inquiries can be easily verified and

- audited by the Wisconsin Department of Transportation.
- 62. In March 25, 2022 Video, ROBERTS once again said the MATHEWSON was violating state law and Wisconsin Department of Safety and Professional Services guidelines by abusing his professional Private Investigator License by using authorities his license grants him "for unprofessional reasons"
- 63. In March 25, 2022 Video, ROBERTS said MATHEWSON located a battered woman at a shelter or monetary compensation, and gave the man her address and she was subsequently beaten badly again.
- 64. The allegations in ¶ 63 were made with ACTUAL MALICE –

  ROBERTS knew the accusations were false or made the allegations with reckless disregard of whether they were false of not.
- 65. In March 25, 2022 Video, ROBERTS said MATHEWSON was violating Illinois State Statutes by practicing Private Investigative Services in Illinois without an Illinois License.
- 66. Although MATHEWSON is not licensed in Illinois, MATHEWSON does not and has never practiced Private Investigative Services in Illinois.
- 67. All of these posts made in public by ROBERTS were seen by the public at large possibly thousands of people.

- 68. In addition to the public posts ROBERTS made about

  MATHEWSON via social media and email, ROBERTS also relayed

  verbally to many members of the public that MATHEWSON is a white

  nationalist.
- 69. In addition to the public posts ROBERTS made about

  MATHEWSON via social media and email, ROBERTS also relayed

  verbally to many members of the public that MATHEWSON is a white
  supremacist.
- 70. In addition to the public posts ROBERTS made about

  MATHEWSON via social media and email, ROBERTS also relayed verbally to many members of the public that trained his children to be suicide bombers.
- 71. In addition to the public posts ROBERTS made about

  MATHEWSON via social media and email, ROBERTS also relayed verbally to many members of the public that MATHEWSON has threatened military veterans with death.
- 72. In addition to the public posts ROBERTS made about

  MATHEWSON via social media and email, ROBERTS also relayed verbally to many members of the public that MATHEWSON is a

terrorist.

73. In addition to the public posts ROBERTS made about MATHEWSON via social media and email, ROBERTS also relayed verbally to many members of the public that MATHEWSON involved in the plot to kidnap the Michigan Governor.

- In addition to the public posts ROBERTS made about 74. MATHEWSON via social media and email, ROBERTS also relayed verbally to many members of the public that MATHEWSON is associated with a terror group out of Michigan.
- 75. In addition to the online videos recorded by ROBERTS and published onto Facebook, ROBERTS told others about the allegations listed in ¶52 orally to others in the community.
- In addition to the online videos recorded by ROBERTS and published 76. onto Facebook, ROBERTS told others about the allegations listed in ¶53 orally to others in the community.
- In addition to the online videos recorded by ROBERTS and published 77. onto Facebook, ROBERTS told others about the allegations listed in ¶54 orally to others in the community.
- 78. In addition to the online videos recorded by ROBERTS and published

- onto Facebook, ROBERTS told others about the allegations listed in ¶55 orally to others in the community.
- 79. In addition to the online videos recorded by ROBERTS and published onto Facebook, ROBERTS told others about the allegations listed in ¶56 orally to others in the community.
- 80. In addition to the online videos recorded by ROBERTS and published onto Facebook, ROBERTS told others about the allegations listed in ¶59 orally to others in the community.
- 81. In addition to the online videos recorded by ROBERTS and published onto Facebook, ROBERTS told others about the allegations listed in ¶62 orally to others in the community.
- 82. In addition to the online videos recorded by ROBERTS and published onto Facebook, ROBERTS told others about the allegations listed in ¶63 orally to others in the community.
- 83. In addition to the online videos recorded by ROBERTS and published onto Facebook, ROBERTS told others about the allegations listed in ¶65 orally to others in the community.
- 84. Defendant ROBERTS published a video to Facebook on May 6, 2022 addressing Plaintiff MATHEWSON.

- 85. In this video, Defendant ROBERTS refers to Plaintiff MATHEWSON as a racist many time.
- 86. Defendant ROBERTS states in May 6, 2022 Facebook video "Kevin Mathewson, who's been writing articles about be for the last six, seven years."
- 87. Defendant ROBERTS states in May 6, 2022 Facebook video "Kevin Mathewson's been talking about me, he literally built an entire newspaper online and I'm like the majority of the content.
- 88. Defendant ROBERTS is making reference to Plaintiff

  MATHEWON's website, Kenoshacountyeye.com in ¶86 and ¶87.
- 89. Plaintiff MATHEWSON is the founder and editor of kenoshacountyeye.com.
- 90. Kenoshacountyeye.com published its first article on September 26, 2020.
- 91. Kenoshacountyeye.com has since published approximately 307 articles.
- 92. Kenoshacountyeye.com has published six articles about Defendant ROBERTS.
- 93. The articles posted about Defendant ROBERTS were:

- 1. October 8, 2020 Roberts was arrested for DUI (Second) and Endangering Safety (Use of a dangerous weapons).
- 2. December 9, 2020 Roberts removed his name from consideration to be nominated to a County Commission of Race and Ethnic Equality.
- 3. January 1, 2021 Follow-up story to Robert's DUI and Endangering safety arrest, he was granted a 1-year adjournment.
- 4. February 15, 2021 Roberts loses custody of two of his children for physical abuse in which he was charged with two felonies of child abuse.
- 5. September 3, 2021 Roberts Plead guilty to DUI (second) and Endangering Safety.
- 6. March 8, 2022 Mathewson sues Roberts
- 94. Six articles out of 308 is about 0.0195.
- 95. 0.0195 is not "a majority of the content".
- 96. Defendant ROBERTS falsely claims in May 6, 2022 Facebook video that Plaintiff's motion for summary judgement was "tossed" by Judge Reddy.
- 97. In fact, there was not any motions for summary judgement filed at the time and date this video was posted.
- 98. Defendant ROBERTS stated in May 6, 2022 Facebook video "A

couple of weeks ago, we had our new people come into office and one of those people had a horrible tragedy where they lost their child violently in our community. Kevin Mathewson couldn't help himself so this family is still going to - I don't think you can ever get over that. This man is running for office. He is now a public figure. I don't have to say his name. Everyone knows who it is. Everyone either knows who it is – you can find out very easily. Kevin Mathewson goes on a public forum, his own forum and he says 'ya, it was horrible what happened to him and his kid but he voted for Bernie Sanders so that makes him some, you know, a communist and everything. He couldn't just focus on him voting for Bernie Sanders. He couldn't just call him a communist, he had to tie in, he had to say it, he had to tie in the death of his child he had."

- 99. Although Defendant ROBERTS didn't mention this man by name, he was referring to Kenosha Alderman Kelly Mackay.
- 100. Like most of what Defendant ROBERTS says about Plaintiff
  MATHEWSON, this was a lie.
- 101. Plaintiff Mathewson never said anything similar to this about Mackay.
- 102. On Saturday, May 28, 2022 at 9:41pm Defendant ROBERTS posted

on Facebook calling Plaintiff Mathewson a "domestic terrorist white supremacist."

- 103. In this post, he also states that Plaintiff MATHEWSON "has written no less than 4 articles on the recent tragedy downtown Kenosha.

  Why? Because he knows the victim is kin of a local minority leader. 4 articles in a matter of days. Simply to spread more hurt and harm.

  This is why I am continuing my legal campaign against him.

  Domestics (sic) terrorists need to be put on notice. As well the women supporting them. As well the families thy train up to follow in their terrorist ways. As well the idiot lawyers and politicians supporting their terror campaigns. We the people must stand."
- 104. A true an accurate copy of this post is attached herein and labeled as **EXHIBIT W.**
- 105. Although not stated, Defendant ROBERTS is writing about Timmy Brooks, who shot and killed his girlfriend.
- 106. Although not stated, Defendant ROBERTS is writing about "local minority leader" Sharmain Harris.
- 107. Although not stated, Defendant ROBERTS was referring to Plaintiff
  Mathewson's wife when he says "As well the women supporting

### them."

- 108. Although not stated, Defendant ROBERTS was referring to Plaintiff's children when he says "As well the families thy train up to follow in their terrorist ways."
- 109. Plaintiff MATHEWSON had no knowledge about the relationship between Harris and the victim in this case (different last names) until Plaintiff MATHEWSON saw Mr. Harris in court addressing the issue of bond.
- 110. Plaintiff MATHEWSON has written exactly two articles about this murder, one on 5-26-22 after learning of the murder and arrest, and the second on 5-28-22 after attending and photographing the initial appearance with permission from the court.
- 111. Defendant ROBERTS saying that Plaintiff MATHEWSON wrote "no less than four articles" is untrue.
- 112. This post is accusing Plaintiff Mathewson indirectly of being racist.
- 113. This story was newsworthy objectively.
- 114. Defendant Roberts is inferring that by Plaintiff Mathewson writing about the Brooks homicide, Mathewson is somehow acting out of racism.
- 115. By Defendant Robert's now setting his crosshairs on Mathewson's

wife and family, he is showing how much actual malice he has.

### **Untrue Assertions of Fact**

- 116. ROBERTS knew at the time of the posts and verbal disseminations that his posts and statements contained untrue information.
- 117. ROBERTS acted with actual malice.
- 118. MATHEWSON is NOT a white nationalist
- 119. MATHEWSON is NOT a white supremacist
- 120. MATHEWSON has NOT trained his children to be suicide bombers.
- 121. MATHEWSON has NOT threatened military veterans with death.
- 122. MATHEWSON is NOT a terrorist
- 123. MATHEWSON was NOT and is NOT currently associated with the plot to kidnap Governor Whitmer.
- 124. MATHEWSON is NOT and NEVER WAS associated with a terror group out of Michigan.
- 125. MATHEWSON has never used his Private Investigator license unlawfully.
- 126. MATHEWSON has never located a battered woman for money.
- 127. MATHEWSON has never practiced Private Investigations in Illinois.

- 128. MATHEWSON did not engage in a conspiracy to run for Alderman, become elected, defund a mostly-minority area, and them move across town.
- 129. MATHEWSON never harassed Augustus Harris, his family, or anyone else similarly situated to Augustus.
- 130. In ¶8, ¶10, ¶16, ¶22, ¶24, ¶26, ¶30, ¶48, ¶50, ¶55, and ¶56, ROBERTS' defamatory statements are defamation PER SE, in that ROBERTS is accusing MATHEWSON of criminal offenses.
- 131. In ¶53, ¶59, ¶62, ¶63, and ¶65, ROBERTS' defamatory statements are defamation PER SE, in that ROBERTS made defamatory statements about MATHEWSON's business and profession.
- 132. In ¶53, ¶59, ¶62, ¶63, and ¶65, ROBERTS' defamatory statements are defamation PER SE, in that ROBERTS made defamatory statements about MATHEWSON's business and profession AND allegations of criminal offenses.
- 133. In Wisconsin, PER SE defamation allegations need not be accompanied by proof of damages or economic loss.

### **Public Response**

134. MATHEWSON was contacted by numerous members of the public following these maliciously untrue assertions of fact by ROBERTS by people believing the assertions were true. MATHEWSON lost business opportunities from people who believed ROBERTS' untrue statements.

### First Cause of Action Defamation

- 135. MATHEWSON does hereby reallege and assert, as is fully set forth herein, paragraphs 1-134.
- 136. ROBERTS has disseminated untrue statements about MATHEWSON
- 137. That the false statement in the posts were made to persons other than MATHEWSON, i.e. the general public and persons within Kenosha County, Wisconsin and around the world.
- 138. That MATHEWSON has a certain standing and reputation within the community that has been damaged by the false statements of ROBERTS.
- 139. That the statements made by ROBERTS were unprivileged and defamatory.
- 140. That the statements and publications made by ROBERTS were made with ACTUAL MALICE, meaning that Roberts knew they were false, in

fact entertained serious doubts as to the truth of the publications, or had a high degree of awareness of the probable falsity.

### **Second Cause of Action**

### Punitive Damages per Wis. Stats. §895.043(3)

- 141. MATHEWSON does hereby reallege and reassert, as if fully set forth herein, paragraphs 1-140.
- 142. That the false statements by ROBERTS were done maliciously with intentional disregard for MATHEWSON's rights.
- 143. That ROBERTS displayed "actual malice" in making such false and defamatory statements about MATHEWSON and either knew such statements were false or with a reckless disregard whether they were true or not.

### Claim for Damages

### WHEREFORE, Plaintiff seeks the following relief:

- For monetary damages to be determined by the trier of fact. A.
- В. For punitive damages pursuant to Wis. Stats. §895.043(3).
- For all actual and reasonable attorney's fees and court fees incurred C. in prosecution of this action.
- For such other and further relief as the Court may deem fair, just D. and equitable.

### Raymond Roberts

Everyone doesn't love every Raymond:

This guy was an alderman when I first came home from Army. I opened my business. He tried to shake me down for 5k to "take surveillance off" of me. My crime you ask?

I bought a small coffee shop in January. My plan including adding a beer and wine license. In anticipation of my license coming through, I started calling vendors whom I already had relationships with. One day a vendor came in to help me plan my initial setup for wine and brought in samples. A customer had been hanging out a while, a little past close. So we simply went to the back and started loading weapons. Needless to say no one was stacked outside.

He saw himself out.

When we talk about the effects of institutional racism, we are talking about how 12% of the population was denied rightful places in society. This also means that people assumed positions they should have never held.

Ray Misner is one of those types of men.

Our recent White Nationalist Commander Kevin Mathewson is another.

These men are the nasty byproducts of a society that denies rightful places to some people, thus allowing individuals that are a detriment for all concerned to instead have the role or position.







That history untaught that results in local elected officials publicly posting things like "and they wonder why African Americans are more likely to go to prison."

Actually Alderman, we don't. We know exactly why. The question is whether or not you do. Sure you will hear individuals claim this history is the past. I counter with a few thoughts and a questions.

This happened in 1958. The adults who did such things, who stood idle when others did s things. Did they have children? Did they raise their children in their own ways?

If the city has an alderman in his late 50s or early 60s, could he possibly have been one of the children, now an adult in a position of influence, raised to see such things as appropriate and normal and just. Could this be why he speaks the way he speaks, acts the way he acts?

Racists Americans from the Civil Rights were not whisped away in some racists rapture the moment MLK JR day was declared. This idea that division over such topics is new is disingenuous to say the least. In fact the people most ardent about selling this myth are equally the ones most likely to do such things or stand idle while others do them as we see below.

The pardon for these boys was done out of remorse but rather the world-wide attention the case received. Our local alderman is not apologizing because he no longer feels that black incarceration is due to system issues, but in the same light, because his actions went viral.

Some say he is apologizing because he got caught. This is not true. When it first became a thing, he stood firm on his behavior. This is no different than when Kevin Mathewson, local white supremacist leader stood firm and demanded that he be referred to as "Commander." It was not until a large enough population started to pay attention that both men started back tracking on their dedication to their stances. This is the coward's way.

The idea that our local elected official is now going to speak with the faith based leaders, this is at most a test for those leaders. If they support the narrative that it is reasonable to offer forgiveness absent consequences, they are no different than the faith leaders who preach peace and grace to the black side of town after the shooting, but have no words of peace and grace for the police before the shooting.

For those who follow my words, you may remember me being suspicious of all the Kenosha community groups that popped up. I stated that I was not sure if they wanted to build a stronger community, or rebuild what was there before the unrest, where things were bad, but better hidden.

This would be a great time to see those groups prove me wrong and demand some "rebuilding" for a "strong" community to move forward. This would be an awesome time to see people who ran for office but did not win, show what they claim to be; champions for all in the community.

Coming back to the original statement about lessons never learned, I guess the only question is whether or not our members of society who missed these lessons.... are they interested in learning the truth? Or have they forever aligned to the malignant and malicious version of history, that version where African Americans are in prison more often because of their culture, or lack of family or their genetics.

The good thing about such trials is that regardless is that regardless of what we all do, it shows who we are. This is an endurance sport. Let's see who is too tired for this round.

County Board,

It has been brought to my attention of allegations presented about me and others who have been nominated for the County Commission Board on Racial Issues.

I would offer two items.

- 1.) Both the individuals that Kevin Mathewson has targeted have been vocal about his involvement with the domestic terrorism, specifical white supremacy militias. Both nominated individuals are actively involved with litigation and efforts against Kevin Mathewson for his roles that we are alleging he has played in several race based activities against ourselves and members of the public. It is to the point that we are working alongside the ACLU to formally organize the body of evidence against Kevin Mathewson. Anyone interested in details on the actual information can definitely contact me or ask for ACLU contacts on the current status of those efforts against Mr. Mathewson and his organization.
- 2.) Mr. Mathewson has created a reputation for misrepresentation and mischaracterization of people that he vendettas against based on race. If the board takes a little time to investigate the items presented by Mr. Mathewson, you will quickly find that the narratives he has painted do not match his wording and voicing. Mr. Mathewson has numerous times been caught using aliases and false identities to present his disinformation, making false police reports and threats, and is now attempting to utilize allege information against public officials in moving forward with the future of our community.

I would recommend that for the sake of not slowing the founding of the Commission, my name be removed as an official board member while those interested review Mr. Mathewson and his organization and supporters' allegation, while also examining the body of evidence regarding Mr. Mathewsons' role as a local leader in the midwest white supremacy movement. My interest to date in such public initiatives has been as a data scientist, which is my current profession. I am able to provide any and all support the county desires analytical solutions whether I am officially sitting on a board or not. Titles are of no consequence regarding such important matters.

While I have directed this to the County Board, I am available for further comment to any and all that were on the original list of Mr. Mathewson. If requested I can even schedule group sessions along with the ACLU to provide context of the work I am currently doing analytically for tracking terror groups and their leader-cells through social media online. This again is how I have come to draw the ire of Mr. Mathewson, but he is not alone. The work is showing there are many others operating as he does.






