I am a concerned black female from Tampa, FL. I do not want to disclose my name because the case I'm writing to you about is a high-profile case and I don't want my name leaked to the public. I'm writing to you to request that you show great leniency on Kyle H. Rittenhouse. He is the defendant in Kenosha County Case Number 2020CF000983 State of Wisconsin vs. Kyle H. Rittenhouse. Mr. Rittenhouse was accused of shooting two Black Lives Matter rioters during a riot on 25 August 2020. I saw videos of the incident on the news and outside of the courage Kyle showed in trying to protect a city from being set on fire by rioters, the only crime he seems to have committed was illegally possessing a firearm. Just because he possessed a gun illegally doesn't mean he can't use it to defend himself. Those rioters attacked Kyle and tried to take his gun from him. Judge Schroeder's comments that the men killed in the Rittenhouse case can be labeled in court as "rioters," "looters," and other highly prejudicial, derogatory terms demonstrates unacceptable bias and an attempt to prejudice the proceedings to favor the defendant. This is a violation of ABA Rule 2.3 and basic professional ethics. If Judge Schroeder is not biased and truly wants to level the courtroom's proverbial playing field, then he would rule against the use of ANY prejudicial language to refer to the men killed. Instead Judge Schroeder is advocating for biased language in proceedings over which he is presiding but clearly attempts to favor the defendant.

Judge Schroeder, do the right thing and recuse yourself. You have demonstrated that you cannot be fair and impartial, and have actually demonstrated a bias in favor of the defendant.

I do not know what the formal complaint process is against judges in Wisconsin, but I am sure the State does know. I sincerely hope they report you to Wisconsin's version of the Judicial Qualifications Commission (this is what we have in Florida). If a judge in one of my cases behaved this way, I'd have submitted a complaint before the ink was dry on the news articles. I'll be looking into whether citizen complaints are accepted in Wisconsin as the judiciary must be above this kind of bias or our entire justice system falls apart. Judges must, above all else, behave ethically. Your behavior, sir, is unacceptably unethical. Kindly do the right thing and step down from this case.

Judge Rossell, do the right thing and move to disqualify Judge Schroeder from presiding over this case if he refuses to recuse himself. Talk to your colleague and help him understand why the taxpayers of Wisconsin deserve better from its judiciary.

To be clear: I don't entirely disagree with Judge Schroeder about the use of the term "victim." It is prejudicial; but "looter," "rioter," and "arsonist," suggests those killed had been tried and convicted of these crimes. They most certainly were not because Rittenhouse's actions denied them due process. Whether or not Rittenhouse committed crimes against these men is up to the jury to decide. A judge is required to stay well clear of biasing the process. Judge Schroeder has demonstrated he cannot do that.
