PROBABLE CAUSE:

On March 23, 2018 at approximately 10:01 a.m., Officer Donald Rowley of the Kenosha Police Department was dispatched to Street in the City and County of Kenosha, State of Wisconsin, after Karen Bloom called the police to check the welfare of her daughter, Caitlyn Hughes. Ms. Bloom reported that she was on the phone with Caitlyn and could hear her adult son, the defendant Anthony Huber, yelling at her, and the call then disconnected. Ms. Bloom was concerned as the defendant has a history of abusive behavior.

Upon arrival at the residence, Officer Rowley met with Caitlyn Hughes, who was very upset and crying. Caitlyn stated that she lives at this residence with her brother, the defendant Anthony Hughes. She stated that on this date, she was in her bedroom when the defendant entered the room and yelled at her about needing an insurance card. Caitlyn told the defendant she would look for it in a little while. She went into the living room to work on a craft project involving wine glasses. The defendant began to yell at Caitlyn loudly about finding the card. Caitlyn began to look through her purse for the card. As she was doing so, the defendant continued to yell and scream about the card and how no one does anything around the house to keep the house clean. Caitlyn threw her purse at the defendant, which caused a wine glass to break on the floor. The defendant stepped on a piece of the broken glass and cut his foot. The defendant then stated, "see what you did" as he went into his bedroom. As Caitlyn began to pick up the broken glass, the defendant came out of the bedroom and kicked her in the right hip, causing her pain without her consent, and she fell into a nearby dog crate. Caitlyn then called her mother. The defendant left the residence prior to police arrival.

Officer Steven Winter of the Kenosha Police Department attempted to locate the defendant. Officer Winter contacted the defendant by telephone. The defendant sounded upset and crying and stated that he was angry at his sister for calling the police on him. The defendant stated that he didn't do anything wrong. Officer Winter encouraged the defendant to turn himself in, but he stated "I ain't going back to jail, I am just going to kill myself." The defendant also told Officer Winter that he cut his foot on some glass at home and that he would need medical attention. Officer Winter obtained a "ping" on the defendant's cell phone, but he was not located in that area.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

Count 4: MISDEMEANOR BATTERY, DOMESTIC ABUSE, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Thursday, December 06, 2012, in the City of Kenosha, Kenosha County, Wisconsin, did cause bodily harm to Richard J. Hughes, by an act done with intent to cause bodily harm to that person, and with knowledge that person did not consent, contrary to sec. 940.19(1), 939.51(3)(a), 968.075(1)(a), 939.63(1)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

And further, invoking the provisions of sec. 939.63(1)(a) Wis. Stats., because the defendant committed this crime while using a dangerous weapon, the maximum term of imprisonment may be increased by not more than 6 months.

Count 5: DISORDERLY CONDUCT, DOMESTIC ABUSE, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Thursday, December 06, 2012, in the City of Kenosha, Kenosha County, Wisconsin, while in a public or private place, did engage in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1), 939.51(3)(b), 968.075(1)(a), 939.63(1)(a) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

And further, invoking the provisions of sec. 939.63(1)(a) Wis. Stats., because the defendant committed this crime while using a dangerous weapon, the maximum term of imprisonment may be increased by not more than 6 months.

Count 6: DISORDERLY CONDUCT, DOMESTIC ABUSE

The above-named defendant on or about Thursday, December 06, 2012, in the City of Kenosha, Kenosha County, Wisconsin, while in a public or private place, did engage in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct, under

circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1), 939.51(3)(b), 968.075(1)(a) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

And further, invoking the provisions of sec. 968.075(1)(a) Wis. Stats., because this charge is an act of domestic abuse, costs upon conviction would include the domestic abuse assessment imposed under sec. 973.055(1) Wis. Stats.

PROBABLE CAUSE:

On December 6, 2012 at approximately 7:31 p.m., Officer Sarah Nord of the Kenosha Police Department responded to Street, City and County of Kenosha, State of Wisconsin for the report of family trouble.

Upon arrival, Officer Nord spoke to Richard Hughes (R.J.), who provided a signed, written statement. R.J. stated that at approximately 2:00 p.m., he was at home (912 75th Street) with his brother Anthony [Huber] (the defendant) and his grandmother (Patricia Hughes). R.J. stated that he lives at that residence with his mother, grandmother, sister, and the defendant.

R.J. stated that he was playing Xbox in his sister's room when the defendant came into the room, started yelling at him, and calling him a "fat fuck." The defendant told R.J. to start cleaning or he would gut R.J. like a pig. R.J. noticed a knife in the defendant's right hand that looked like a butcher knife, was approximately 6 inches long, and had a green handle. The defendant held the knife up and then down by his side. The defendant came toward R.J. and told him to start cleaning. R.J. stated that he was afraid the defendant was going to stab him.

R.J. walked out of the room, and the defendant followed him. The defendant threw a chair and some clothes across the room. The defendant yelled again that he was going to kill R.J. if he didn't clean. R.J. stated that he was afraid, so he started picking up stuff. R.J. stated that his grandma was in the living room and looked scared, so she began picking up stuff, too.

The defendant sat down with the knife in his hand and watched them while they were picking up. The defendant told R.J. if he stopped, he would kill R.J. R.J. stated that this went on for about a half hour. R.J. grabbed his keys and laptop and made his way to the front door. The defendant yelled at him and told him that he was not allowed out of the house. R.J. turned around, and the defendant put a knife to R.J.'s stomach, saying that he was going to gut R.J. like a pig. R.J. bent down to try to protect himself. The defendant grabbed R.J. by the neck and dug his nails in. R.J. stated that he hurt and he though the defendant was going to choke him. The defendant held his hand to R.J.'s throat for about 10 seconds, and R.J. could not breathe. The defendant finally let go, and R.J. bent down again to protect himself.

The defendant put the knife to R.J.'s left ear. R.J. felt the blade and believed his ear was cut. The defendant backed up for a second, and R.J. noticed that his ear was bleeding. R.J. put the keys and computer down and continued cleaning. R.J. went to use the bathroom and saw the defendant looking for the house phone. R.J. stated that he didn't feel that he could leave the house, or the defendant would cut or stab him. R.J. hit the "record" button on his cell phone and put it in his pocket.

R.J. came out of the bathroom, and the defendant started yelling at him, wanting to use R.J.'s cell phone. The defendant was screaming and swearing. After a few minutes, the defendant calmed down but still had the knife in his hand. R.J. stepped outside with the garbage and believed the situation had diffused.

The defendant demanded that his grandma take him to the skate park, and she did. R.J. waited for his mother to come home. They went to dinner to discuss what they should do. R.J. and his mother (Karen Bloom) decided to call crisis.

Upon arriving home, R.J. told the defendant that he had two options: involve the police or go to the hospital with R.J. to get help. The defendant refused to go with R.J., started yelling at him, and called him a "fat fuck." R.J. then called police. The defendant came outside and started chasing R.J. while he was on the phone with dispatch. The defendant then ran back inside and took off on a skateboard.

R.J. stated that he was afraid for himself and other family members. The last thing the defendant said before leaving was, "I'm gonna burn the house down with all you fuckers in it!" [COUNT 6]

R.J. did not give anyone consent to threaten him, choke him, or make him fear for his safety. R.J. indicated that he hoped the defendant would get help with his anger and depression issues.

Officer Nord observed a tiny cut on the top, back of R.J.'s ear and a small scratch on the right side of R.J.'s neck.

Patricia Hughes provided a signed, written statement, similar to that of R.J.'s. Patricia stated that the defendant went to the kitchen, came back with a large butcher knife and put the knife at R.J.'s neck and stomach. The defendant was slashing at R.J. The defendant also threatened to cut of R.J.'s fingers. Ms. Hughes stated that the defendant was preventing them from calling for help. Ms. Hughes was scared to go to her purse to get her cell phone out. Ms. Hughes was also scared that the defendant as going to stab or cut R.J.

Ms. Hughes stated that she told R.J. just to leave. When R.J. would try to leave, the defendant would say, "I dare you," and put the knife up to R.J.'s throat. The defendant also said, "I can slit your throat. I can gut you up and down." Ms. Hughes stated that she took the defendant to the skate park, and everything was fine.

R.J., Ms. Hughes, Karen Bloom and Caitlyn H. (DOB 4/30/1997) were also present for the evening incident where the defendant threatened to burn down the house.

The defendant arrived home while Officer Nord was still responding to the call. The defendant was very lethargic but cooperative. The defendant told officers where the knife was. Officer Martin Howard of the Kenosha Police Department located a silver knife in a kitchen drawer. R.J. indicated that he was 100% positive that this knife was the one the defendant had been using earlier.

The family indicated that the defendant had been making suicidal statements before leaving the house.

- > Statements by citizen informant(s) Richard Hughes, Karen Bloom, and Patricia Hughes; who are eyewitnesses to the facts they relate;
- ➤ The official records of: The Circuit Court for Kenosha County; The Department of Transportation; The FBI Triple I Teletype; The Wisconsin Circuit Court Automated Program, which records are maintained in the normal course of business duties.
