#### NARRATIVE

On 08/16/18 at approximately 1727 hours I PO Jones-Denson 651 responded in full KPD uniform and in fully marked squad to the front counter of the Public Safety building for a Battery complaint.

On arrival, I made contact with a male who was verbally identified as Nicholas Aaron Keeran. Nicholas stated that he works for the Kenosha Fire Department. Nicholas stated that today 08/16/18 around 0915am he was at Poerio Park located at 1401 16th Ave along with a group of fire fighters.

Nicholas stated that he was getting ready for softball practice when he observed a male later identified as James D. Adams walk up to another member of the fire department who was identified as Cory R. Cage. Nicholas stated that James got in Cory's face and started poking him and yelling at him. Nicholas stated that James told Cory that he heard that Cory was talking about him. Nicholas stated that James told Cory that he was going to break his neck if he keep talking about him. Nicholas stated that he stepped between James and Cory.

Nicholas stated that he told James that he needed to calm down and he needed to hear the whole story. Nicholas stated that James got upset with him and stated that he did not like Nicholas and Nicholas knows why. Nicholas stated that he told James that the issues between them were over a year old and James needed to let it go. Nicholas stated that James snapped and grabbed his neck with both hand and started squeezing. Nicholas stated that he could not breath from the pressure that James put on his neck. Nicholas stated that James was choking him for about 6 to 8 seconds. Nicholas stated that he did not lose consciousness but he couldn't breath. Nicholas stated that James picked him up off the ground and drove him back into a gate until other people interveened.

Nicholas stated that James punched him in his left ear with a closed fist which caused him pain. Nicholas stated that the fight broke up at that time. Nicholas advised that he feared for his safety and he did not give James permission to choke him or hit him or cause him pain. See Nicholas statement for more information.

After speaking with Nicholas, I made contact with James by phone. James stated that he arrived at the park 1401 16th Ave around 0915 today 08/16/18. James stated that he saw Cory and he went to confront Cory because he heard that Cory was saying bad things about him. James stated that he and Cory started arguing when Nicholas stepped in and put his hands on James chest. James stated that he told Nicholas that he did not like him. James stated that he thought Nicholas was going to hit him so he went at Nicholas first. James stated that he pushed Nicholas up on a fence and held him there. James stated that the other people broke up that fight at that time.

After speaking with James, I made contact with Cory by phone. Cory advised that he was at the park with Nicholas and the rest of the softball team today 08/16/18 when James walked up to him and got into his face. Cory stated that James stated that he heard that Cory was talking about him and he was going to break Cory's neck. Cory stated that Nicholas stepped between he and James. Cory stated that Nicholas told James that he needed to hear the whole story and to calm down. Cory stated that James got upset with Nicholas and started choking Nicholas. Cory stated that James pushed Nicholas up against a fence and the knocked him to the ground. Cory stated that James punched Nicholas in the face before the fight was broken up.

Nicholas advised that he would like to sign a complaint at this time. There were no marks or brusis on Nicholas person. Nicholas refused medical attenetion. Nothing further to reprot at this time.

#### SUPPLEMENTAL NARRATIVE

### **Detective Summary**

On 08-17-20, I assisted Detective Eric Kukowski 577 on this case. We responded to Poerio Park (1401 16th Ave) to meet with the victim and potential witnesses in this case. At the park I made contact with William Swanson (verbal) who is a firefighter with the Kenosha Fire Department.

William provided a written statement regarding what he observed on 08-16-18 at Poerio Park. According to William, he was at the park with six other Kenosha Fire Department employees. Along with William, there were: Ryan Anderson, Cory Cage, Matt Chada, Nate Lutze, Nick Keeran, and James Adams. Will was practicing on the baseball diamond with other people when he heard yelling coming from the dugout that is attached to the field. The dugout is not below ground, and is a chain-link fenced in area attached to the field. William stated that he saw James Adams, Cory Cage, and Nick Keeran inside of the dugout area. James was screaming at Cory, but William did not hear exactly what was being said; Cory appeared calm when this yelling was happening. Nick attempted to calm James down by saying "We need to talk about this". According to William, James turned his attention from Cory on to Nick, and started to scream at Nick. After about a minute of James screaming at Nick, without provocation, James grabbed Nick with both hands around the neck. James proceeded to lift Nick up with both hand around his neck completely off of the ground. James held Nick like that for approximately 5-7 seconds. At that time James let go of Nick's neck and let him down, James then reached back with his hands (William was unsure which one) and struck Nick one time, causing Nick to fall to the ground. Nick went into the fetal position and James began to strike Nick multiple times while he was down.

William stated that after James had Nick on the ground, he went into the dugout to try and pull James off of Nick. William wrapped James in a bear hug from the back and started to pull James away. Ryan Anderson came in to help pull James away. It took both William and Ryan to pull James away from Nick to prevent a further assault on Nick. See William's statement for additional information.

Follow Up 08-20-18

I took a statement from Ryan Anderson, who was also present for this assault. I took a

statement from Ryan which outlines the same version of events as William.

Ryan stated that the seven listed subjects were on scene practicing for a softball game. Ryan observed Nick, Cory, and James inside of the attached dugout. James was yelling at Cory, at which point Nick attempted to intervene by talking with James. James becomes upset with Nick, wraps his hands around his neck, pushes him against the fence, and eventually punches Nick while Nick is on the ground. Ryan did not know how long James had Nick grappled by the neck, and he stated he did not see if James lifted Nick off the ground or not. Ryan stated that it took him and William pulling James away to stop James' attack on Nick.

Detective Investigation

08/17/18

I reviewed the report submitted by PO Jones-Denson along with the statement signed by Nicholas Keeran.

I met with Nicholas at Poerio Park at approximately 1700 hours. Nicholas pulled up to the park with William Swanson (VER) and Cory Cage. Nicholas had previously mentioned to KPD that he wanted to cancel his complaint. I spoke to Nicholas and he expressed his desire to move forward with the complaint against James Adams. Nicholas stated William (Will) Swanson and Cory Cage were both present for the incident and witnessed the battery.

PO Antaramian #583 obtained a witness statement from William. See his report.

I obtained a written statement from Cory Cage (VER). Cory stated on 08/16/18 at approximately 0915 hours at Poerio Park he was with numerous Kenosha Fire Fighters to practice softball. Cory was with Nate Lutze, William Swanson, Matthew Chada, Ryan Anderson, and Nicholas Keeran. They were at the north baseball diamond by the dug out. James Adams (also known as JD) arrived last. He pulled up, walked over to the diamond, didn't say hi to anyone, and immediately dropped his belongings. James walked directly to Cory and started yelling at him reference Cory trash talking him at work. Cory tried to reason with James and said whatever James had heard is false. James continued to scream and proceeded to poke Cory in the chest with his finger. James told Cory if his name came out of his mouth ever again he would break his neck. After this comment was made, Nicholas told

James he needed to hear the truth from Cory. James then directed his focus to Nicholas and was yelling at him reference a personal issue from one year ago. James put both hands around Nicholas's neck and started to squeeze. Nicholas was lifted off the ground a couple inches off the ground by his neck/throat by James and his face turned red. James had Nicholas pinned up against a fence inside the west dugout and continued to choke him. After choking Nicholas, James released one hand from his throat and threw a punch that landed on the side of Nicholas's head. Nicholas then dropped to the ground and went into the fetal position. James started to punch him with closed fists numerous times to his ribs and back. William Swanson pulled James off of Nicholas and the other individuals present held James back. Nicholas got up while James pointed at Cory and said "You're fucking next!" Cory believed this statement to be serious and thought James was going to beat him up next. James went onto the field and eventually started practicing while Nicholas left. Cory estimated the entire physical act lasted 20-30 seconds. See statement.

I met with Matthew Chada (VER) around 2115 hours and obtained a written statement. Matthew stated on 08/16/18 between 0915 and 0930 hours, he was on the NW ball diamond with Nate Lutze playing catch. While playing catch, William Swanson, Ryan Anderson, Cory Cage, Nicholas Keeran, and James Adams showed up. James started screaming at Cory while getting in his face over Cory trash talking him at work. James was also poking Cory in the chest while screaming. Cory was trying to tell his side of the story and did not react to James's aggressive behavior. This took place in the opening of the west dug out. Nicholas then told James to calm down and knock it off. James proceeded to get into Nicholas's face and screamed at him about a personal issue from one year ago. Nicholas asked why James was even bringing that issue up and James snapped. Nicholas had his hands at his side, did not react to James, and tried to deescalate the situation.

Matthew observed James grab Nicholas around the neck with both hands and lifted him off the ground a few inches. James directed Nicholas back into a chain link fence. Matthew estimated Nicholas was off the ground between 5 and 10 seconds. Nicholas's reaction to being lifted off the ground was shock, his mouth was open, and he appeared to be in trouble. Matthew believed at this point Nicholas was going to be injured by James. James then tried to punch Nicholas in the head which either grazed the side of his head or completely missed.

Nicholas dropped to the ground and covered his head. James continued to punch Nicholas while he was down. Matthew confirmed one punch (closed fist) landed to Nicholas's body because he heard a thud. Mathew stepped in and controlled James's left arm while William Swanson controlled James with a bear hug from behind. James was physically trying to get to Nicholas through the individuals control him. William was able to pull James to the infield away from Nicholas and hold him there. Nicholas got up and said he was okay. Nicholas left while James was fine in a matter of five minutes. See statement.

I made contact with Nathaniel Lutze at approximately 2200 hours and obtained a written statement. Nathaniel stated on 08/16/18 at 0930 hours he was at the NW ball diamond at Poerio Park with Matthew Chada. They were the first two to arrive and were examining home plate along with playing catch. During this, William, Ryan, Cory, Nicholas, and James (JD) showed up. These individuals were in the west dug out when Nathaniel heard yelling and observed James face to face with Cory. James was yelling and pointing at Cory over Cory saying something behind James's back. After yelling at Cory, James turned to Nicholas who was about 3 feet away in the dug out. James then pushed Nicholas up against a chain link fence with both hands around his neck. James had Nicholas pinned up against the fence between 15 and 30 seconds. James started throwing "haymakers" (powerful punches) at Nicholas while standing. Nicholas went into the fetal position against the fence. James punched Nicholas in his side and back with closed fists. James threw at least five punches, but only landed one. Nathaniel stated he is not the confrontational type and stayed at home plate. Will ran to the dug out and took control of James by utilizing a half nelson. As Will pulled James out of the dug out, James was still trying to get to Nicholas physically. James was taken down the first base line as Nicholas took a walk in the infield. James then grabbed a bucket of softballs and wanted to start practicing. Nicholas decided to leave since James was staying. See statement.
