

During third hour health class a boy named got angry to another kid named and broke the kid's chromebook. He said he was going to house to kill him. He then left class and said that the whole class was cooked.
Peter and came into my office where we discussed the information we had obtained. When questioned initial stated "I didn't say anything". I then read the two above tips that came in. Peter advised that we know there was something said based on having multiple students saying otherwise. The eventually ended up telling us that she was just giving people an update. The advised she told one of the girls at her table "your cooked". The advised she meant this as "those kids might get in trouble". The advised "I never said I was going to go to someone's house and kill them".
After speaking with Peter and I spoke with two individual witnesses regarding this investigation. Both students relayed similar information indication that and and good "go back and forth a lot. An example they gave was a conversation as follows: stated "shut up with your high pitched vocal cords" responded "shut up you have higher vocal cords then me".
The two student's witnesses described overhearing 3rd hand information from other students in the class. They reported one of the statements they overheard had allegedly told to come to his house so he could kill him legally.
The student witnesses described seeing an incident in health class during their third period class. They observed exchanges words across the classroom and advised didn't get up right away but instead sat starring at When did get up they he walked toward and grabbed his chromebook and attempted breaking it before throwing it to the ground. (This made a small indentation in the wall that was later photographed). Then took homework assignment and started ripping it up. Then stated "you're not going to pass it anyways retard". Both student witnesses explained when came back she grabbed her backpack and told the class "ya'll are cooked". When asked what she meant the students replied "it means you're in trouble".
Following the witness interview Peter and I again met with made a statement come over so I can kill you. In response said that had told her something about (coming to her home) so she told "Well don't do that because that would be a home invasion. When I asked if she thought of that statement "come over to my house so I can kill you legally", as a threat she advised "it does not". Advised that "I wasn't saying I wanted it to happen, but I wouldn't let you break into my house". When asked, said she did not recall how the conversation initially began.
