Kevin E. Mathewson, being first duly sworn, states as follow:

My name is Kevin E. Mathewson, and I am an adult resident of Kenosha County. For the last 10 years, I have been an advocate for justice and good government, having served as an elected Alderman, and now, an Investigative Journalist. I hereby submit this affidavit in support of the attached Petition for a John Doe Proceeding, Pursuant to Wisconsin Statute Section 968.26(2), in the possible felony bail-jumping of Clyde J. McLemore.

Introduction

1. On or about February 19, 2021, Clyde J. McLemore (DOB 2-5-1959) "McLemore", was charged in Kenosha County Circuit Court with

one count of attempted battery to a law enforcement officer (Class H Felony) and disorderly conduct (Class B Misdemeanor).

- 2. According to the criminal complaint, it is alleged that McLemore kicked closed a door in an attempt to break a Kenosha Police Officer's fingers on August 24, 2020, during the Kenosha Riots of 2020.
- 3. The criminal complaint is attached hereto and incorporated as Exhibit A.
- On or around February 24, 2021, McLemore was given a signature 4. bond that he and / or his attorney signed.
- 5. The signature bond is attached hereto and incorporated as Exhibit В.
- A condition of this bond, states very clearly that defendant 6. McLemore "shall not commit any crime."
- On October 3, 2022, while still out on bond McLemore was 7. arrested and charged with Illinois 720 5(21-5a) Criminal Trespass to State Supported Land (Class C Misdemeanor).
- 8. According to the charging document, McLemore was arrested at Waukegan, IL City Hall because he would not leave when asked.
- 9. The charging document is attached hereto and incorporated as Exhibit C.
- 10. Utilizing the Illinois F.O.I.A. statute, I obtained the police report,

body-worn camera footage, and City camera footage of McLemore's behavior that led up to his arrest and his arrest.

- 11. The police report is attached hereto and incorporated as **Exhibit D**.
- 12. A true and accurate depiction of Waukegan Police Officer Kevin Sanchez's body-worn camera footage be viewed can at: https://youtu.be/JY1KKsLSMrU
- A true and accurate depiction of an unknown Waukegan Police 13. Officer's body-worn camera footage viewed can be at: https://youtu.be/ESmPDsmqX3A
- 14. A true and accurate depiction of the Waukegan City Hall footage can be viewed at: https://youtu.be/nm02rAOmVgw
- 15. After watching the video, it is clear that McLemore was loud, boisterous, profane and disorderly during the Waukegan City Hall meeting, called the mayor a bitch, and refused to leave when ordered by police.
- On October 21, 2022, I made Kenosha County DA Graveley and 16. Walworth County DA Zeke Wiedenfeld aware of this new crime allegedly committed by McLemore.
- On November 16, 2022, I sent the video footage and report to 17. Kenosha County DA Graveley and Walworth County DA Zeke Wiedenfeld.
- To date, neither DA has responded to my request for Mr. 18.

McLemore to be charged.

- 19. Upon information and belief, neither DA intends to charge McLemore for Wis. Stat. §946.49(b).
- 20. McLemore has an extensive criminal history and has been convicted of felony aggravated battery to a police officer for allegedly dragging a deputy from a moving car.
- 21. McLemore's Illinois criminal history from the Illinois State Police is attached hereto and incorporated as **Exhibit E**.
- 22. Investigation is needed to determine why McLemore wasn't charged.
- 23. McLemore should be charged with Felony Bail Jumping, §946.49(b).
- 24. If the reason McLemore was not charged is prosecutorial discretion, the undersigned believes this discretion is being abused and a Judge should intervene in the interest of justice.

The undersigned, being first duly sworn, states that:

Count 1: ATTEMPT BATTERY TO A LAW ENFORCEMENT OFFICER

The above-named defendant on or about Monday, August 24, 2020, in the City of Kenosha, Kenosha County, Wisconsin, attempted to intentionally threaten to cause bodily harm to Steven W. Winter, a law enforcement officer, without their consent, and at the time of the act, the defendant knew or should have known that Steven W. Winter was a law enforcement officer and the act was in a response to any action taken by a law enforcement officer in an official capacity, contrary to sec. 940,203(2), 939,50(3)(h), 939,32 Wis. Stats., an attempt to commit a Class H Felony, and upon conviction may be fined not more than Five Thousand Dollars (\$5,000), or imprisoned not more than three (3) years, or both.

Count 2: DISORDERLY CONDUCT

The above-named defendant on or about Monday, August 24, 2020, in the City of Kenosha, Kenosha County, Wisconsin, while in a public or private place, did engage in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1), 939.51(3)(b) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

PROBABLE CAUSE:

On August 24, 2020 at approximately 2:23 p.m., Kenosha Police Detective Peter Falk was on duty when he was made aware that Mayor Antaramian was doing a press conference at the Public Safety Building (PSB), 1000 55th Street, in the City and County of Kenosha, State of Wisconsin, which was moved from the Civic Center Park due to safety concerns.

Upon Mayor Antaramian's arrival at the PSB, an unruly crowd formed and attempted to force their way into the PSB. All available officers and the Civil Disturbance Response Team (CDRT) were

called in to dispel the crowd and get the doors to the PSB closed. Officer Steven Winter was part of the CDRT and the officer that was able to pull the door closed.

Detective Falk was subsequently contacted by someone who wanted to remain anonymous, who stated a known activist and self-proclaimed founder of the Lake County Chapter of Black Lives Matter, Clyde McLemore, the defendant, posted images of himself on his Facebook page from the incident. Detective Falk stated the image(s) in question reportedly showed the defendant kicking the front door of the PSB and bragging that he was trying to break the officer's fingers who was pulling the door shut.

Detective Falk looked at the defendant's Facebook page and reviewed known images of the defendant as reference when reviewing images/videos going forward in the investigation. Detective Falk found the image in question, which was posted on August 25, 2020 and had a caption with it saying people were asking the defendant the context of the photo. The defendant claimed a Kenosha Police Lieutenant grabbed a black girl, used her as a shield, got inside and grabbed the door to close it. The defendant stated the officer's hands were in the door and he was mad enough to try and break the officer's fingers, indicating his intent that accompanied his kicking the door.

Detective Falk stated there was a comment telling the defendant that the image allowed him to be caught red handed and he should be more careful and others made comments that tended to encourage the defendant's actions. One woman made a comment telling the defendant that he was a disappointment and by taking such actions, he was leading by example and should not be the founder, referring to his self-proclaimed position as the founder of the Black Lives Matter chapter in Lake County, Illinois. The defendant responded "and you are a white woman who should be in your place."

The defendant posted the same image with the words "Black Lives Matter" embedded in it, suggesting he took such actions as part of the Black Lives Matter movement. The defendant is also seen holding something in his hand as is if he was recording his actions during the incident. Detective Falk uncovered that the defendant frequently posted Facebook Live videos and found a series of videos the defendant made on August 24, 2020, which depicted his actions before, during, and after the incident at the PSB. Detective Falk stated the defendant is wearing the same black t-shirt and glasses as seen in the image of him kicking the door. The defendant is also seen at the front of the PSB when Mayor Antaramian entered the building. There is also a video of the defendant in the unruly crowd who is trying to force their way into the building. Detective Falk stated clearly identifiable officers, including Officer Winter, were at the door where subjects in the crowd were yelling, acting in a threatening manner, and throwing objects at Officers. Officer Winter grabbed the door to pull it shut, which is when the defendant is seen running toward the door, which is followed by a bang, and then the defendant retreating, which is consistent with him kicking the door. The defendant then made a comment that he was trying to break the officer's hands.

Detective Falk also uncovered videos posted by Fox 6, which showed the incident from a different angle and clearly showed the defendant kicking the door just moments after Officer Winter cleared his hands. Detective Falk also located another video posted by Yahoo, which showed the defendant clearly being the one who kicked the door.

Officer Winter stated while he was attempting to secure the entrance to the PSB, he was met by aggressive, violent, and disorderly protesters who were attempting to forcefully pull the entrance

doors from him while throwing full water bottles and other solid objects at them. Officer Winter stated he was unable to pull the front entrance door closed at first, forcing him to grip the exterior of the door, exposing his fingers and hands. Due to the unruly crowd, the door had been damaged at the hinge area where the door fastened to the frame, making it difficult to secure. Officer Winter stated as he pulled the door closed, he heard and felt a loud/hard slam against the door towards him as he pulled it closed.

Your complainant is an attorney with the Kenosha County District Attorney's Office, who bases his/her knowledge of this complaint on:

- > The official law enforcement agency reports of the Kenosha Police Department prepared by Detective Peter Falk and Officer Steven Winter, which reports were prepared in the normal course of law enforcement duties;
- > Statements by the defendant, which were made contrary to his penal interests;
- > The official records of: The Circuit Court for Kenosha County; The Department of Transportation; The FBI Triple I Teletype; The Wisconsin Circuit Court Automated Program, which records are maintained in the normal course of business duties.

On 10/03/2022 at approximately 17:54 I was working an Extra Duty Detail at City Hall 100 Martin Luther King Jr. At approximately 19:46 during the City Hall meeting a subject who was identified as Mclemore, Clyde was approached by Chief Zupec due to Clyde being loud, disruptive and a disturbance to those attending the City Council meeting.

Chief Zupec attempted to talk to Clyde and asking him to calm down and leave which he did not follow. Chief Zupec then advised Clyde he was under arrest and that is when I placed Clyde in handcuffs and walked him out of the meeting. 




