Dear Judge Dougville,

Trenton Kmiec was convicted of Ct. 2 Bail Jumping-Felony and Ct. 3 Bail Jumping-Felony in Kenosha County file 23CF829. Sentencing was withheld and Mr. Kmiec was placed on three years of probation supervision on 09/11/2023. Upon sentencing, he served 107 days local jail time on Ct. 1 Obstructing an Officer. Upon his release he reported for supervision immediately.

On 04/30/2024, Mr. Kmiec reported for an appointment and a UA was conducted. Mr. Kmiec tested positive for Fentanyl with very faint lines for Methamphetamines and Cocaine. Mr. Kmiec was adamant that he did not consume any illegal substances. Mr. Kmiec was ordered to return two days later and did report on 05/02/2024. His UA came back negative for everything.

On 05/03/2024, Agent Saunders received a voicemail from Mr. Kmiec stating he had police contact the night before, but did not know why. Upon further investigation and obtaining a police report, it was learned that Mr. Kmiec suffered an overdose needing medical attention and four doses of NARCAN. When Agent Saunders questioned Mr. Kmiec about the incident he insisted, once again, that he did not consume any illegal controlled substances and did not know why he overdosed.

On 08/26/2024, Agent Saunders received notification that Mr. Kmiec was being held in custody for an overdose incident on 08/23/2024. Mr. Kmiec was found by a friend slumped over the steering wheel of his vehicle and needed medical attention due to agonal breathing. Mr. Kmiec received two doses of NARCAN and was revived. Upon getting his statement, Mr. Kmiec admitted to smoking Marijuana the night of the incident, but stated he did not consume any other illegal controlled substances. During that statement Mr. Kmiec also admitted to consuming cocaine multiple times between 07/26/2024 and 08/23/2024.

Due to Mr. Kmiec's continued drug use, the Department is respectfully requesting 90 to 120 days conditional jail time be imposed as a response to hold Mr. Kmiec accountable as well as for his own safety. This will provide the Department time to have him completed drug assessments and set up support services for after his release back into the community.
