SUPPLEMENTAL NARRATIVE

On 02/12/18 at 0057 hrs Officer Genthner #672 and I, Officer B. Valeri #581, started to respond to the area of 1120 80th St reference a 911 hang up. While en route we were advised that they received an additional 911 hang up from 7732 14th Ave. A female, K█████ Williams, was on the phone and stated she was a runaway, someone gave her drugs and she wanted to turn herself in. They stated she was running because she thought the guy who gave her the drugs was going to kill her. We were in fully marked KPD squad 3311 in full KPD uniform.

While checking the area Officer Genthner located K█████ walking northbound on 15th Ave from 78th St. She waved us down. K█████ had on a pair of sweatpants, a black unzipped jacket and a blue bra on. She said she needed help and that she had taken LSD. She had her cell phone in her hand and handed it to me. The phone kept dying because of the cold. K█████ was acting very paranoid. She kept looking around and would just keep asking for help. We tried to tell her she was safe but she thought someone was trying to kill her. Her pupils were very dilated. I tried to get K█████ to sit in our car so we could attempt to speak with her in a warm environment, but she said she didn't trust us.

Dispatch advised us that K█████ had a warrant for her arrest for a weapons offense. Officer Genthner placed her under arrest. K█████ refused to get into the squad car and tensed her body so she couldn't be pulled in. I had to go to the other side of the squad car and pull her through. I had requested a rescue squad for K█████. When KFD MED 2 arrived on scene we attempted to assist her onto the gurney and move the handcuffs to the front. She started to scream that we were going to kill her and begged for help. She tensed her body, tried to pull her arms away and dropped herself to the ground. She had to be physically lifted from the ground and placed onto the gurney. She continued to throw herself forward on the gurney and refused to relax so they could cover her and place the straps on her. I rode with K█████ as MED 2 transported her to Froedtert South Kenosha Campus for medical clearance. In the ambulance she refused to let KFD place the blood pressure cuff on her or get any vital signs. She was ultimately transported to ER Room #1 for medical treatment.

K█████ wasn't initially giving us a lot of information regarding her whereabouts and activities tonight. She had told me that the address given (7732 14th Ave) was just one that she was by when she called 911. K█████ however asked for help getting some of her belongings from the home before she was taken to detention. She then confirmed that the address given was where she was at and she was with her friend Randy (legal name Randall) Volar (in house information). According to our records Randall lives at that given address.

At the PSB I attempted to speak with K█████ a few more times regarding her relationship with Randy. I informed her that I was concerned about her welfare in that home. The conversation started in holding cell 1179, as she started to talk to me more we moved to interview room 1180F and I initiated the video recorder in this room. The holding cell is also under audio and

video surveillance.

K████ stated she met Randy at the 2017 Junteenth celebration in Milwaukee. Some time in June 2017 she was at his residence in Kenosha and they had sexual intercourse. K████ stated there was no forced used during this incident. She was 14 years old at this time. She has kept into contact with Randy since this incident. K████ is currently on juvenile probation. She stated she had been using drugs and missing school. She knew that she was going to be locked up at her court hearing on December 21, 2017 so she chose to flee her home. She cut off her ankle monitor and left. She stated she knew they would come to her home and arrest her if she stayed there, so she chose to leave. K████ called Randy and he picked her up. This was either 12/16/17 or 12/17/17. She has been living with Randy ever since. K████ stated Randy takes care of her. Randy feeds her, provides her with money and clothing. She denied that they currently have a sexual relationship. She told me that Randy is a "father figure" to her and that he looks at her as his niece. K████ denied doing sexual acts in return for money. She denied additional sexual acts between her and Randy. She stated Randy never tried to force her into having sexual contact with him and did not ask her to have sexual contact with anyone else. Randy provides K████ with alcohol, marijuana and LSD. She stated that Randy provided her with drugs in the past and gave her the LSD today. The LSD was on a sheet that they swallowed. She stated this was a "bad trip" and she had not had this reaction to LSD the last time she took it. K████ admitted to consuming marijuana and alcohol "HpnotiQ" at Randy's home on 02/11/18. After K████ realized that she was having a bad reaction to the LSD she grabbed the phone and called the police. Randy was really upset that she called and went into his room. K████ thought he was going to grab a gun and was going after her to kill her. She was scared so she grabbed her phone and just ran. She did not actually see a firearm. She stated Randy talked about getting a gun once, but she is not sure if he actually has one. I asked K████ if she ever thought Randy had done anything sexual to her while she was under the influence of alcohol and/or drugs. She did not think so.

K████ denied any form of sexual contact today. She said the bra she had on was really a bralette and is the shirt she chose to wear today. She stated that Randy took her to Cracker Barrel to eat today. Randy told her that she was going to attract the wrong kind of attention in the outfit she was wearing, but K████ said she likes attention. K████ stated that she mostly spent time inside Randy's house because she knew she was wanted. When they go out Randy always drives the speed limit so they do not get stopped.

K████ said she was aware of Randy's affinity for younger girls. She stated that he is "kind of weird" and needed help in this area. Randy has been very open with K████ regarding his sexual relationship with minors. K████ told him he needed to find a "girl his own age." K████ stated she's the only one currently living with him in the home. Randy used to have his 17 year old girlfriend "J████" living there, but stated she was locked up and is no longer there. J████

██████ is the only 17 year old female with that name in our records. Since I am not sure if this is the J ██████ that K ██████ was referring to, she was not added to the call. There was also a 16 year old girl there for awhile too. K ██████ said Randy starts his relationships with girls through the app "Tagged." She also mentioned his "backpage girls." She stated the girls are sometimes brought to the home for sex, sometimes he goes to meet them and sometimes he goes to Milwaukee to find young girls. She stated that he spends a lot of money showering young women with gifts and taking them out to eat. Randy has earned most of his money through bitcoin. Randy drives a BMW car. Randy has videos of his sexual relationships with the minor children. K ██████ saw the videos on his computer and on his cell phone. K ██████ was not sure if he ever video taped her. She was not sure what device he used to video tape the sexual acts.

K ██████ did not want to provide me with a written statement regarding this. She was going back and forth about talking to me and providing me with the information she did. She stated she didn't want him in any trouble, but was upset that he had given her the drugs. She stated that K ██████ is super sweet to her and has been there for her so she could not betray his loyalty. K ██████ was aware the interview was recorded.

K ██████ was ultimately turned over to the Kenosha County Sheriff's Department for transport. See Officer Genthner's report for additional information.

NARRATIVE

On 02/12/18 at 0059 hours I, Officer Genthner 672, and Officer B. Valeri 581 were dispatched to a 911 Hang Up call that was mapping in the west sector of the Sheridan Lanes cell tower. We were in full Kenosha Police uniform and in marked squad 3346.

While enroute to the 911 hang up, Dispatch advised they had received another call from the caller, K█████ Williams (verbal, confirmed by guardian). K█████ had taken LSD and was trying to turn herself in. Dispatch advised she was mapping at 7732 14th Ave, later identified as Randy Volar's (verbal) address.

While I was searching the area I found K█████ walking northbound at the intersection of 78th PI and 15th Ave. K█████ was appeared to be very agitated upon first speaking with her. K█████ eyes were very dilated, she kept glancing around and appeared to be paranoid. K█████ was patted down by Officer B. Valeri. When Officer Maccari 634 arrived in his squad car, K█████ starred at the vehicle's approach and appeared to be afraid of the vehicle. Even after being reassured that it was a police car, K█████ continued to stare at the vehicle. At one moment while I was attempting to warm up my hands, K█████ asked me why I had my fists clenched. K█████ almost broke down in tears while asking the question and even as I informed her I was trying to warm my hands up she continued to stare. K█████ continued to glance at my hands even while they were open.

K█████ appeared to be very confused and scared while officers talked to her. K█████ was initially cooperative with police by giving us her information. K█████ stated she was turning herself in because she was a runaway. K█████ had also cut off her ankle bracelet that she had to wear since she was on probation. K█████ stated that she had left her friend Randy's house. K█████ later identified Randy as Randy Volar. Officers attempted to make contact with Randy at his address but were unable to do so. K█████ was wearing a black Michael Kors winter jacket that was unzipped with only a bra on underneath and advised that she was cold. K█████ was visibly shivering and when officers attempted to have her sit in the back of a squad car she became very afraid, uncooperative and refused to get in the squad car.

K█████ was identified by Dispatch and they advised she had a warrant out of Milwaukee Co for SS 948.60(2)(a) possession of a dangerous weapon <18 yoa. K█████ was arrested for the warrant and I placed K█████ into handcuffs which were checked for fit and double locked for safety and comfort. K█████ was searched incident to arrest. K█████ later advised that she was aware of the warrant and she was turning herself in for that warrant. The warrant was later confirmed by Milwaukee Co. After K█████ was arrested she became very agitated and started screaming "you're going to kill me". K█████ asked for rescue at this moment. K█████ was placed into to back of my squad and I activated my squad recorder. K█████ attempted to kick out the rear passenger side window of the squad car.

Med 2 arrived on scene. K[REDACTED] was taken out of the squad car and she continued to yell that we were going to kill her. I attempted to take my handcuffs off of K[REDACTED] but she continued to struggle and I was unable to take the handcuffs off. K[REDACTED] was forced on to the ambulance gurney and as she was being placed into the back of the ambulance K[REDACTED] was giving out high pitched screams. K[REDACTED] was transported to Froedtert Hospital South (6308 8th Ave) by Med 2.

At Froedtert K[REDACTED] was treated by the hospital nursing staff. K[REDACTED] had to be handcuffed to the hospital gurney due to her agitation. While in the hospital K[REDACTED] continued to shiver even with multiple blankets on her. K[REDACTED] identified Kathy Barren (verbal) as her legal guardian. I spoke with Kathy on the phone and she was aware that there was a warrant for K[REDACTED] arrest. Kathy knew K[REDACTED] had runaway and thought K[REDACTED] had been picked up by a slim built 17 year old male when she ran away. Kathy was unaware of further details of the male but believed he had a partial plate of WI/AAA00.

I spoke with Kenosha Co Juvenile Crisis agent Amy Rosenberg. I informed Amy of K[REDACTED] arrest and that she was currently at Froedtert due to her drug induced state. Amy made a note of the case, but since K[REDACTED] was in the hospital and would not be held in custody by Kenosha, Amy did not respond to Froedtert.

Milwaukee was unable to come to Kenosha and take custody of K[REDACTED] I spoke with Kenosha Co Juvenile Intake agent Jeanine Riess. Jeanine stated Kenosha Co would take K[REDACTED] into custody and transport K[REDACTED] to Racine Co. Jeanine stated that she would meet us at the PSB to complete the necessary paperwork.

K[REDACTED] was medically cleared from Froedtert Hospital by Dr Charles Longdon and I transported K[REDACTED] to the PSB. Before the transport I again placed K[REDACTED] into handcuffs that were double locked and checked for fit. At the PSB I placed K[REDACTED] into a secure holding cell (room #1179, audio recording) and completed an interrogation room monitoring log. Jeanine arrived to the PSB and I completed a temporary physical custody request document. Officer B. Valeri spoke with K[REDACTED] while at the PSB. K[REDACTED] was pictured and printed by Kenosha Joint Service. K[REDACTED] was released into the custody of Kenosha Co Sheriff Deputy Preston 246 for transport to Racine Co Juvenile detention.

SUPPLEMENTAL NARRATIVE

On 02-21-2018 at approx. 330pm I met with and interviewed the suspect in this case, 15yr old K Williams, at the Milwaukee County Juvenile Detention Center located at 10201 Watertown Plank Rd in Milwaukee, WI. I was assigned this case after Williams had spoken with Officer Valeri #581 and told her that she had been prostituting herself out and had done so with a Kenosha Man named Randy Volar.

Williams told me that she first met Randy Volar last year during the JUNTEENTH FESTIVAL in Milwaukee, WI. Williams stated that she had placed an ad on BACKPAGE offering herself as an "ESCORT" and that Randy had called her, offered her \$250.00 for a night of sex and that Randy drove up to Milwaukee, WI and picked her up and brought her back to his house in Kenosha, WI, an address she stated was 7732-14th Ave where they had both Oral Sex and penis to vagina Intercourse. Williams was 14yrs old at that time and based on my observation of her, she looks 14-15yrs old. Williams stated that Randy used a condom. Williams described Volar as being born with only three fingers on his right hand and that his right leg, although it has a foot on it, is approx. 6 inches shorter than his left leg. According to Williams, Volar would call her on at least two more occasions to have sex with her but that those two times, he met her in Milwaukee, WI picked her up and the two went to a hotel in Milwaukee, WI where they had sexual intercourse after Volar paid her \$100.00 each time. Williams stated that Volar knew she was only 14yrs old when they first met as they discussed her age numerous times with Williams telling Volar he needed to find a girl his own age to have sex with but Volar stated that he liked younger girls because their "PUSSIES WERE NICE AND TIGHT" and that the older girls pussy's were worn out and too loose. Williams stated that each time they had sex, Volar would video tape it with his cell phone. Volar even played back video clips of the two of them having sex to Williams and also showed Williams video clips of himself having sex with other underage girls. Those video clips were shown to her from his home computer. Williams stated that she and Volar became friends and that she could call him whenever she wanted to get away and he would come pick her up and bring her back to his house in Kenosha, WI. Williams stated that she had a connection in Milwaukee, WI to obtain Marijuana and anytime Randy Volar came to pick her up they would always stop at her dealer and get some marijuana to bring back with them. Williams stated that anytime she needed money Volar would give her some. Anytime she wanted to go shopping Volar would take her. Williams stated that when she first met Volar he wasn't as rich or wealthy but that Volar had invested in "BITCOINS" and that he recently cashed some out and was flush with approx. \$200,000 dollars. That's why Volar had purchased a slightly used BMW car that was black in color. Williams stated that she even met and went to dinner with Volar's mother. According to Williams, she only had sex with Volar those three times but that Volar was hanging out and having sex with other underage girls whom she only knows by their first names of "JAYA" or "JAYLA" approx. 17yrs old, TYLER approx. 17yrs old and CRYSTAL

Williams described the house as a One Bedroom house with no basement or garage. The kitchen has nice stainless steel appliances and he has a projection screen TV in the living room. There is an odd scary type of picture in the living room of a DEVIL with an ANGEL too. Williams stated that it was Volar who always supplies her with alcohol to drink and that his favorite drink is rum and coke. Williams also stated that it was Volar who gave her the LSD to try as well on the evening of 02-15-2018.

Williams asked that I try and obtain her personal belongings that she left at Volar's residence. Those included a pair of black knee high boots, a Gucci Book Bag, a NIKE bag with new clothes in it and a laundry basket containing her dirty clothes. Williams refused to make any type of written statement and said she didn't want to get Randy in any trouble as he was nice to her and took her places and she liked to hang out with Randy.

SUPPLEMENTAL NARRATIVE

On 02-22-2018 Detective Traxler #426 drafted a SEARCH WARRANT for 7732-14th Ave based on the police reports and information given by the victim, K Williams. At approx. 1239pm myself and Detective Traxler #426 with the assistance of Sgt Farchione#417, Street Crimes Officers Wicketts#578 and Hancock#566 and Patrol Officers Kopp#438 and Henderson#673, the Search Warrant was served at 7732-14th Ave. I knocked on the door and announced our presence but no one answered. I directed Officer Wicketts to use the ram and breach the front door and he did so, entering the home immediately through the front door and encountering the suspect, Randall Volar, in his living room dressed only in a pair of sweat pants. Volar was ordered to the ground and handcuffed without incident. Volar was identified via his WI DL and was advised of the search warrant. After getting Volar some clothes to wear he also was allowed to attach his prosthetic right leg and special shoe. Volar was un handcuffed and I advised him that he was only detained until we gained control of his house for purposes of the search warrant to make the area safe. I walked Volar to my unmarked squad car parked on 78th street in the 1400blk and he sat in the front seat area. I activated a digital micro recorder and I explained to Volar that he was not under arrest and was free to leave at any time but that he was no free to enter his house during the execution of the search warrant. I asked Volar if he wanted to talk with be about why we were there and I explained to him I knew about him traveling to Milwaukee, WI and paying underage girls to come back with him to Kenosha to his residence at 7732-14th Ave for the purposes of having sex with them. I also explained to Volar that I knew he filmed some or all of those sexual encounters with his phone and has those video's both on his phone and on his home computer. Volar remained silent and stated he thought it was best that he not say anything. At no point did Volar request an attorney. Volar was concerned about getting some information from his desk top in order to access his Bit Coin money. I advised Volar that the more he cooperated the quicker and easier things would be for him and he would probably get his belongings back sooner. Volar and I would engage in some conversation such as where he lived and was he raised in Kenosha and where he had worked previously but Volar never spoke about why Officers and Detective were there for the Search Warrant. After approx. an hour I summoned another marked squad over to my location and Officer Held responded. I advised the suspect, Randall Volar that he was now being placed under arrest and he was handcuffed by Officer Held and placed in his squad car. Officer Held would transport Volar to the PSB Detective Bureau and I followed him down. Volar was placed in an interrogation room until an arrest report could be completed. When I advised Volar that this would be the final time for him to be able to talk with me if he chooses to do, Volar had a change of heart and said he thought would want to talk. I placed Volar in Interview room #1180 and completed a waiver form and read it to him. Volar thought about talking with me after I read to him the line where I wanted to talk about him having sex with underage girls and he ended up changing his mind. I documented the form to reflect his change of mind, no questions were asked of him and he was placed back in the

Interrogation Room. A little while later I spoke with Volar in the Interrogation room and advised him that he was going to be booked and released pending a summons and complaint. Volar inquired as to when he might get any of his computer drives back or a thumb drive as his passwords were on them and he needed the passwords to access his bit coins and exchange them for US Currency to retain a lawyer. I explained that I didn't have an answer for that, but if he changes his mind about wanting to talk with me that he can talk with his lawyer and contact me and they can come down together and talk. Officer Held took Volar for pictures and fingerprints and he was charged with the following, pending examination of the evidence and possible additional charges:

- 1) 2nd DEGREE SEXUAL ASSAULT OF A CHILD 948.02(2) FELONY
- 2) CHILD ENTICEMENT 948.07(2) FELONY
- 3) USE OF A COMPUTER TO FACILITATE A CHILD SEX CRIME 948.075(1r) FELONY
- 4) EXPOSE GENITALS TO A MINOR 948.07(3)

Upon bringing Volar back from getting booked, Volar stood in front of my desk and volunteered that the stuff i was looking for would be on a black in color 128GB thumb drive in the trunk of his car. I never asked Volar any questions either before he made this statement nor did I after he made the statement. I placed Volar back in the Interrogation Room and then met with Officer Kopp in Evidence and she confirmed that they had already retrieved a black 128GB thumb drive from the suspects truck as well as a number of hard drives.

Because the door to Volar's residence had been breached and I was uncertain if it could be locked again, when the search was concluded, Detective Traxler stayed at his residence until Volar could be booked and brought back to his house so that no one could enter the house and Volar could secure the door on his own.

At approx. 530pm I received a phone call from Volar stating that all of his passwords and such were kept on a 5GB thumb drive, almost identical to the one in the trunk, and that he would need the passwords to access his money "BIT COIN" and asked that if I could as soon as I could I at least get the password to his GMAIL Account so he could access the gmail and Bit Coin Info. I told Volar I would see what I could do but I would make no promises.

On 02-23-2018 a Warrant was written by myself and later signed by Court Commisioner David Berman to have any and all of the seized items examined by Officer Morton for any evidence of Child Porn and any Video's made by the suspect of himself having sex with any underage girls.

At approx. 132pm on 02-23-2018 I received a phone call from Attorney Johnathan Smith

A. INTRODUCTION

Your affiant states he is employed as a law enforcement officer with the City of Kenosha Police Department for over 19 years and has been involved in the investigation of violations of State and Federal laws. Your affiant is currently assigned to the Detective Bureau and has been for over 5 years.

B. BASIS FOR THE REQUEST FOR THE SEARCH WARRANT

1. I base this affidavit on personal knowledge and information provided to me which I believe to be reliable; statements made in my presence, as well as information provided by other law enforcement officers. This affidavit is made for the purpose of establishing probable cause in support of the accompanying request for a search warrant and therefore contains only a summary of the relevant facts. I have not included each and every fact known to me concerning the entities, individuals, and events described in this affidavit. In the course of your affiant's experience, your affiant has been involved in investigations of violent crime.
2. I am aware that the current investigation involves the use of computers or other digital devices and that the data stored on such devices may be relevant and probative evidence in any subsequent investigation or prosecution. I know from my training and experience that digital data can be recovered from storage devices/media even after long periods of time. However, I also know that digital devices or storage media (hard drives, USB drives, CD's, DVD's, etc.) can be easily concealed, moved, destroyed or damaged and thereby prevent a forensic analysis of the contents of those devices, even if they can be located.
3. I am currently assisting Detective May #301 of the Kenosha Police Department, who was assigned to a sex crimes investigation that occurred at 7732 14th Ave,

which is located in the City and County of Kenosha, State of WI. We are seeking a search warrant for a residence involved in this case resided in by the suspect, Randall Phillip Volar III M/W 10/01/83 and any vehicles that may be parked on this property.

4. On 02-12-18 at around 0057 hours, PO Valeri #581 and other officers of the KPD responded to 7732 14th Ave reference a 911 call at 7732 14th Ave. Kayla M. Williams F/B 09/17/2002, was on the phone stating that she was a runaway, that someone had just given her drugs, and who was now trying to kill her, and she wanted to turn herself in.
5. Kayla was located by PO Genthner #672 in the 7700 block of 15th Ave while walking on foot. Kayla, who appeared very nervous and stated that she had taken LSD. A check of records showed that Kayla had a capias out for her arrest, was arrested, and was taken to KMH for evaluation based on her statement of ingesting LSD.
6. Kayla later informed Valeri that she met Randy at a Juneteenth celebration in Milwaukee and in June 2017, at his residence in Kenosha, they had sexual intercourse together. Kayla continued that she knew at her next Juvenile Court hearing that she was going to be incarcerated so she cut off her ankle monitor, called, Randy who picked her up in Milwaukee and brought her to his house at 7732 14th Ave on either 12-16-17 or 12-17-17 and she has been living with him ever since.
7. Kayla described Randy as a "father figure" to her that he provides her with marijuana, LSD, and alcohol and she took LSD earlier today at Randy's that he had provided to her and she is having a bad reaction to it. Kayla continued that Randy got upset with her when she called 911 for help, threatened to kill her, and threw her out of the house. Kayla was later turned over to KSD for transport on her Capias.
8. On 02-21-18 at around 1530 hours, May, met Kayla at the Milwaukee County Juvenile Detention Center and obtained a verbal statement from her there. Kayla stated she placed an ad on Backpage offering herself as an escort and that Randy contacted her and offered her \$250 for a night of sex. Kayla continued that she accepted his offer, drove up to Milwaukee, picked her up, drove her to his house in Kenosha at 7732 14th Ave where they performed oral sex on each other and had penis to vagina sexual intercourse as well.
9. Kayla stated that on at least 2 other occasions that Randy called her on the phone and the two of them had sexual intercourse/contact at motels in Milwaukee and that Randy had paid her \$100 for each of those evenings.
10. Kayla stated how on the first night she told Randy that she was only 14 years old and how Randy needed to find a girl his own age. Kayla continued how Randy replied that he liked younger girls because their "Pussies were nice and tight" and how older's girls pussies were worn out and too loose.
11. Kayla advised how Randy had videotaped, with his cell phone, each of their sexual encounters and that Randy had played these videos back for her showing them having sexual contact. Kayla continued how Randy also showed her videos on his home computer of him having sexual contact with other underage girls as well.

- 12. Kayla mentioned some of the other girls that Randy hangs out with as "Jaya" or "Jayla" who she believes is 17 years old, Tyler around 17 years old, and Crystal about 17 years old as well.
- 13. Kayla informed May that on the night of her arrest that she left some personal belongings at Randy's residence which she described as a pair of black colored knee high boots, a Gucci Book bag, a Nike bag, and a laundry basket containing her dirty laundry.
- 14. Your affiant is aware that "Backpage.com" is a website that offers an adult section that includes ads for: escorts, body rubs, strippers and strip clubs, and adult jobs. To access that portion of the site, you must agree to view pictorial nudity and adult language. Based on the training and experience of this detective, the ads for "body rubs" and "escorts" contain adult pictures and terms that are used in the adult industry to signify sexual relations for cash or considerations. The KPD has responded to ads on Backpage and conducted investigations leading to arrests for prostitution and pandering with the initial basis for the investigation being the ad on Backpage.
- 15. A check of DOT files showed that Randall's address is 7732 14th Ave which he updated on 11-24-15 and he just had a new DL issued to him on 02-15-18 with the address on 14th Ave.
- 16. On 02-21-18, May observed black colored BMW parked in the driveway at 7732 14th Ave, bearing WI auto registration, ABX-5138, with a VIN WBAFU7C55DDU77243. A registration check on the vehicle shows it registered to Randall at the address of 7732 14th Ave City and County of Kenosha, State of WI.



SUPPLEMENTAL NARRATIVE

On 02-22-18, I, Detective Traxler #426 began assisting Detective May #301 with a sex crimes investigation. I drafted a Search Warrant for the residence which was signed by Commissioner Berman at 0959 hours, authorizing the search.

At 1239 hours, I and other KPD Officers arrived at the residence, where we served the search warrant and Vollar was located inside the residence. May before he walked Vollar out to his squad car asked Vollar where his cell phone was at and Vollar pointed at the couch. I looked at where Vollar pointed at and I observed a cell phone on top of one of the cushions which I pointed out to PO Kopp #438 and PO Henderson #673, who were acting as ET's on this search warrant, to collect that phone for evidence. During the search of the residence/property, I observed the following items which I had Kopp and Henderson photograph and collect, in the kitchen, on the counter, along the northern wall, I observed a opened bottle of Hpntoiq brand liqueur, from the bedroom, in a white colored box at the southern end of the bed a pair of black colored knee high boots, from the bedroom floor a grey colored tub filled with various powders, leafs, and needles, from the bedroom closet a pair of pink colored pajama pants, from a garbage bag that I located on the outside porch/east side of the residence, a opened bottle of San Juan brand rum. As Kopp and Henderson were still inside the residence, I went to the black colored BMW that was parked in the driveway and as I started my search of the vehicle in the center console I observed a hotel receipt from Milwaukee, WI. I stopped searching, had Kopp and Henderson come out to the vehicle, take photographs, collect the receipt and continue searching the vehicle.

During a search of the vehicle, Kopp located a bottle of pills in the glove box without a prescription label on them. I looked at the pills and saw that they were a blue and orange colored capsule with "S489 70mg" written on the capsule. At 1411 hours, I called the Walgreens' located at 3805 80th Street, spoke to the on-duty Pharmacist, that I identified verbally as Jackie, and she identified the capsule as Vyvanse 70mg, or generic Adderal. Jackie continued that it is a schedule II stimulant as well and stated how Vollar doesn't have a prescription for this medication either.

At around 1600 hours, PO Held #549 returned Vollar to the residence where I was still at, awaiting his return to turn the residence over to him. I asked Vollar if he had a prescription for the Vyvanse and he informed me that he didn't. I informed Vollar that a copy of the search warrant was on his kitchen counter and I turned the keys to the car and the residence over to him and Held and I cleared the residence at 1602 hours.

I returned to the PSB, completed the Return on the Warrant and filed it and all of the warrant related paperwork with the Court Officer.

SUPPLEMENTAL NARRATIVE

On 02/23/18, Det. May requested I examine several devices that were collected in a sexual assault of a child and possession of child pornography investigation. Among the items collected were four SIM cards (items #13-16). Data from all of the SIM cards was extracted using the Cellebrite UFED unit, and processed using Cellebrite Physical Analyzer software. None of the SIM cards had any user data on them and only showed the subscriber ID, home carrier area information and, if assigned, a telephone number. Reports on all four SIM cards were generated and placed on a disc.

Item #18 was found to be an SD card reader, with no SD cards inserted, so there was nothing to examine. All DVDs packaged as item #8 were given to Det. May to review. He later advised nothing relevant was found on them. All DVDs packaged as item #41 were also given to May. He later gave them back and advised one contained possible child pornography. See attached exam report.

Case relevant evidence was found on the Sandisk USB drive item #40, the Western Digital drive item #39 and the Crucial drive found in the custom computer listed as item #1. Case reports on all of these items was generated. All reports and case files were put on a disc and given to Det. May for review. Due to time restraints and not having the needed equipment, the XBox (item #2), the RAID array (items #6 & possibly #37) and the Lenovo laptop (item #3) could not be examined at this time. All case reports and files were placed into evidence. See attached exam reports for more details on these and other items that were examined.

SUPPLEMENTAL NARRATIVE

Upon Officer Morton completing the exam of some of the various items taken in the Search Warrant there were numerous home made video's with the suspect, Randy Volar, videotaping himself having sex with a number of different girls, some white females and the others black females. Almost all of the girls looked to be in their early teenage years but a few, including the two white females, appear to possibly be 18yrs old or close to it. The home made video's were labeled either with a date or a date and a name. Listed below is a list and description of the video's:

- 1) 11-30-2013- shows a dark haired white female appear to meeting with Randy Volar in a hotel room and the two engage in oral sex and vaginal sex.
- 2) 08-24-2014 a short video clip of an ice bucket challenge-no nudity
- 3) 07-23-2017 Randy Volar having sex with an unknown black female in his bed at his house- the female appears to be in her mid teens
- 4) labeled by phone# & name- 4143802725 JADE- another teenage black female having sex with Randy Volar at his home in Kenosha on a pullout couch in the living room-
- 5) same video as above but appears from a different angle
- 6) ALEXANDRIA MP4- shows an older white female appears over 18yrs old have sex with Randy Volar in his bedroom on his bed.
- 7) April 18 2014- very brief video that shows the female undressing from the waist down in a hotel room- no face at all
- 8) Kelly MP4- shows Randy Volar and an unknown black female who appears to be mid teens wearing a pink bra and panties, they get naked and have oral and vaginal sex in Volar's home.
- 9) KellyCherryPopped- Shows Randy Volar having sex with a Different Female Black who appears to be close to 18yrs old, dark skinned and a larger framed female black.
- 10)05-25-2017- Video shows Randy Volar video taping himself while holding his phone in what appears to be Volars bedroom while a Female Black girl who appears to be 12-14yrs old gives him oral sex. Female black has a hair wrap on
- 11)05-25-2017- Video with same girl listed in #10 continues- this time in a bedroom on a bed with Volar having vaginal sex and the girl again giving him oral sex. Same hair wrap on
- 12) 05-31-2017 -appears to be the same female black as listed above in #10 and #11 again giving Randy Volar oral sex and again vaginal sex.
- 13) 05-31-2017-same girl this time being filmed by Randy Volar as he has "Doggy Style" ex with her from behind and films it with his cell phone, commenting she must be on her period as he has blood on his penis

- 16) 06-20-2017-a female black in her mid teens with a black cap covering her hair engaging in oral and vaginal sex with Randy Volar in his bedroom of his house
- 17) 06-28-2017- female black again approx. mid teens with Pink Hair having sex with Randy Volar on his bed in his bedroom, oral and vaginal sex
- 18) 07-26-2017- Randy Volar having sex with an unknown female black who appears to be early teens as he films it with his cell phone as he is having sex with her from behind commenting on how "fresh" and "tight" her vagina is.

K████ stated she recalled being shown the video labeled 08-24-2017 by Randy Volar in which the girl is shown dancing like a stripper. K████ saw the video marked 09-27-2017 103946 MP4 showing a girl naked in bed drinking from a liquor bottle and she stated that was the girl she knows as "JAYLA" that she became friends with and had been picked up with several times in Milwaukee by Randy Volar and had sex with. The remaining photos were also all of "Jayla".

I then asked K████ about some other video's that I could not take any still shots of because they all had graphic nudity in them. I described a video of a female black in her early teens giving oral sex to Randy Volar as something red was wrapped around his penis. K████

Item #41 Various DVD's, with one of them having 16 Video Files on it, all 16 Video's were already in the National Center For Missing and Exploited Children (NCMEC) Database as Child Pornography with (6) of the video's having Identified victims. See Report

Item #40-Sandisk 128GB USB Thumb drive- This contained the numerous Home Video's recorded by the suspect of him having sex with Numerous females, a few white but most are black and most appear to be in their teenage years, from 14-17yrs old. One of them, Labeled June 19,2017 is of the Suspect and the Victim in this case, K██████████ engaging in Oral Sex. Williams stated that Volar contacted her by Phone and picked her up in Milwaukee, WI at the Junteenth Festival on June 19th 2017 and brought her back to his house at 7732-14th Ave in Kenosha, WI where he paid her \$250.00 to have sex with him. Williams stated she recalled being videotaped and wrapping a Fruit Roll-up around Volars penis and giving him oral sex. Williams stated she was wearing a Brown "GUCCI" baseball hat and had red hair that night. The video found confirms this. See Report

Item# 39- Western Digital Hard Drive- This drive contains not only some of the same home made sex video's found on the Thumb drive listed above, but also hundreds of other video's of child pornography involving girls that appear to be between the ages of 12yrs old and 16yrs old. some examples are listed below:

Video- labeled Siberian Mouse Custom- shows an approx. 12yr old female white girl naked and having objects/fingers placed in her Anus by an adult male. The girl then performs oral sex on an adult male until this male ejaculates in the girls mouth

Video- 53A43EB5- Naked F/W approx. 13-14yrs old masturbating with her fingers and a pen for a web cam.

Video- 533C9DB2- Two girls dancing for a web cam again approx. 13-15yrs old as they get naked and fondle each others breasts and vagina's

Video- 533CADED- Labeled "CHEERCHICKS123"- Two girls again appearing to be 13-15yrs old get naked in front of a web cam showing their breasts and vagina's and dance

Video- 533CFEAE- A F/W approx. 14-15yrs old dances for a web cam, gets naked and masturbates with her finger and a long glass object inserted inside her vagina in addition to fondling her breasts for the camera

Video- 5161E6AB- F/W approx. 13-15yrs old gets naked on Web Cam and masturbates with her fingers

Video-5346FB4 (two) Female Asian girls approx. 13-15yrs old get naked on camera and fondle each other and masturbate each other while they kiss each other and roll around together on a floor.

This is just a small section of the number of Pre-teen and Teenage Pornographic Videos found on this Hard Drive. The suspect, Randall Volar III had already been booked and released on the first (4) charges listed below pending and more thorough Investigation. Based on the evidence thus far and statement from K██████████ Williams I am also adding Possession of Child Pornography as well.
