AS WE TURNED AROUND DISPATCHER ADVISED US THAT HE HAD STOPPED AT 376<sup>th</sup> AVE AND STH SD. AS WE PULLED UP WESTPHAL WAS STANDING OUTSIDE OF HIS VEHICLE TALKING ON THE CELLPHONE. WESTPHAL WAS PLACED IN THE BACK OF OUR SQUAD FOR HIS SAFETY WITHOUT INCIDENT.
