NARRATIVE

On June 14, 2023, as a Detective assigned to Special Investigations Unit, I was made aware of a search warrant that was executed at 932 Center Street - Lower regarding an on-going investigation being conducted by RAPD into a shooting /attempted homicide incident that took place at 1518

Washington Avenue on 06/01/2023 (RAPD #23-21644) by Lt Smith.

Lt Smith informed me during the criminal investigation, investigators executed a search warrant at the same location (932 Center Street) on 06/06/2023 related to the incident looking for the suspects and any possible evidence. During the execution of the search warrant on 06/06/2023, the suspects were not located. Lt Smith later learned the family / suspects at 932 Center Street may have received insider information related to the investigation and search warrant.

Based on the suspicion of compromised intelligences I reached out to one of my cooperating sources (CS). In talking with the CS, I was informed the family at 932 Center Street was receiving information from someone in the Racine County District Attorney's office. The CS did not know the name but thought it was someone in a supporting role.

The CS stated the person providing information was a white / female who was in an intimate relationship with Jeremy Koker Jr. Koker is a direct family member to the suspects in the shooting. The CS stated the female from the DA's office drove a white vehicle and described it as a possible Ford Explorer. Based on the information provided the female was later identified as [REDACTED]

The CS stated after the shooting incident occurred Koker reached out to [REDACTED] (which they believe to be by phone) to see if [REDACTED] could provide any information related to the criminal case. After reaching out to [REDACTED], Koker was in possession of paper / hard copies of police reports related to the the incident. The CS believes the documents were obtaining sometime between 06/02/2023 and 06/05/2023. The CS was not able to provide phone numbers for either Koker or [REDACTED]

The CS stated believes [REDACTED] was the person who typed up the criminal complaint and warrants in the DA's office. After the search warrant was executed on 06/06/2023, [REDACTED] reached out to Koker to inform him about the arrest warrants that were going to be issued for his siblings. The CS believes [REDACTED] sent messages to Koker via text messaging with photographs of the criminal complaint and charges for the suspects.

The CS stated after the search warrant on 06/14/2023 the family was aware that investigators were asking questions about the compromised intelligences. Due to RAPD asking questions about the compromised intelligences family members told both Koker and [REDACTED] to dump there cellular phones and get new phones and phone numbers.
