I pled guilty to what I did and took full responsibility for my actions. I did my time, probation, and paid all the restitution to everyone involved. I have regretted my actions and have done everything I could to make up for what I did by helping my community.

With my current business, I work daily with Fire/Rescue Departments, as well as local Law Enforcement.

The Village of Salem Lakes showed the trust in me by appointing me Commissioner on the Police and Fire Commission, I am currently serving a five year term.

I would like to do even more for my Community and a Pardon would open new horizons to do even more.

Since these mistakes, I have devoted my life to helping my community to make up for what I did. I have organized the annual spring clean up in Salem Lakes for the last ten years, where I organize volunteers to clean up the community. and get food donations for our local food pantry.

During the Salem lakes floods of 2017, I organized 360 volunteers to help people in out community clean up when the homes were destroyed.

I also serve on the Salem Lakes Fire Commission. I have been a Commissioner since 2018, when I was appointed to the position.

I have worked hard to try to make a better name for myself.
